

## ORDINANCE 2009-01

### AN ORDINANCE INCORPORATING the updated TOWN OF VERONA OPEN SPACE AND PARKS PLAN, including text and map revisions as an AMENDMENT to the TOWN OF VERONA COMPREHENSIVE PLAN

**WHEREAS**, the Town of Verona Board adopted an ordinance approving a Town Open Space and Parks Plan on April 11, 2000; and

**WHEREAS**, the Town of Verona Open Space and Parks Commission has worked in cooperation with the planning departments of County of Dane Parks, City of Verona Parks and the Ice Age Trail Foundation to draft revisions to the text of the plan and to propose a Town of Verona Open Space and Parks Map; and

**WHEREAS**, the Town of Verona Open Space and Parks Commission has reviewed the proposed draft text and map dated January 2009 and revisions were made; and

**WHEREAS**, the Town Plan Commission held a public hearing on August 27, 2009 in which the Commission solicited public input as to the proposed text revisions and draft map; and

**WHEREAS**, the Town Plan Commission has approved resolution 09 - A that recommends to the Town Board that the Town of Verona Open Space and Parks Plan and Map dated September 2009 be included as Appendix B in the Town of Verona Comprehensive Plan ; and

**WHEREAS**, the Town Board of the Town of Verona has reviewed the proposed open space plan text and map dated September, 2009 and notes the following:


- a) the mapping for the most part mirrors the Dane County Parks and Open Space Map,
  - b) the areas outlined on this map are informational and for future planning purposes only and cannot be used for or against any land use division or rezone action by any agency, committee or municipality,
  - c) concurs with the Plan Commission and the Open Space and Parks Commission;

### **NOW, THEREFORE, THE TOWN BOARD OF THE TOWN OF VERONA, WISCONSIN DOES ORDAIN AS FOLLOWS:**

That the Open Space and Parks Plan Text, Town of Verona map dated September 2009, attached hereto as Exhibits (A-Text) & (B-Town Map) and for additional informational purposes the Dane County Parks Plan Map (attached hereto as C), is incorporated as a part of the Town of Verona Open Space and Parks Plan as an exhibit and is made a part of the Town of Verona Comprehensive plan as an exhibit known as Appendix B – The Town of Verona Open Space and Parks Plan.
