Statutes, Specifically a Proposed Tax Levy Which Would Exceed the Allowable Town Tax Levy for 2019 payable 2020, before adjustments, by 2.5 percent, for a dollar increase of \$28,404.
9. To Approve the 2019 Total Town Tax Levy to be Collected in 2020 Pursuant to s. 60.10(1)(a) of Wis. Statutes.
