Ordinance 2016-2

Amending Town of Verona Ordinance Number 2015-2, entitled Chapter 3 Fire Protection and Prevention Code

The Town Board of the Town of Verona pursuant to its authority under Section 60.555 of Wisconsin Statutes does hereby amend the Town of Verona Chapter 3 Fire Protection and Prevention Code, Subchapter II, subsection 3.24 and does ordain as follows:

1. Section 3.24 (1) is hereby amended so as to repeal the list of items (a) through (g) defined locally as fireworks and amended to include a list those items excluded in the definition of fireworks as stated in Section 167.10 of Wisconsin Statutes within the same section;
2. Section 3.24 (4)(a) is hereby amended so that the minimum number of days prior to an event for filing an application with the Town Clerk-Treasurer from 45 days to 10 days;
3. Section 3.24 (4)(a)2 is hereby amended so that the application shall include the telephone number of the person who will set off fireworks for the business entity at the time and on the date of the requested permit;
4. Section 3.24 (4)(a)3 is hereby amended so that the application shall include the date or alternate date if the original date is unsuitable;
5. All citations in Section 3.24 that refer to the Town Board or Town Board Chair is hereby amended to read Town Board Chair or designee;
6. Section 3.24 (4)(c) is hereby amended to include two new conditions for approval by the Town Board Chair or designee:

The Town Board Chair or designee may consider reports alleging a violation of a federal or state law or municipal ordinance regulating the handling, storage, sale, use or other activities involving fireworks, firearms or explosives by the applicant, which reports did not result in a conviction of or a charge against the applicant;

The Town Board Chair or designee may consider complaints received with regard to fireworks usage by the applicant including, but not limited to, noise, traffic, parking, consumption of alcohol, and deposit of spent fireworks beyond the applicant's property;

7. Section 3.24 (4)(d) is hereby amended to include a new condition for approval: The hours of usage of fireworks are limited to 9:30 AM to 10:30 PM on the day of permitted use;
8. Section 3.24 (5) is hereby amended to include an additional restriction available to the Town Chair or designee: The Town Chair or designee may cancel a permit based on dangerous conditions arising at the time of the permitted usage.
