Town of Verona Dane County, Wisconsin Ordinance 2018-7

Amending Town of Verona Ordinance Number 2015-02, entitled Chapter 3 Fire Protection and Prevention Code

The Town Board of the Town of Verona pursuant to its authority under Section 60.555 of Wisconsin Statutes does hereby amend the Town of Verona Chapter 3 Fire Protection and Prevention Code, Subchapter II and does ordain as follows:

- 1. Section 3.21 (1) (c) is hereby amended so as to update the reference from SPS 310 to ATCP 93;
- 2. Section 3.22 (3) is hereby amended so as to update the reference from sec.3.40 to sec 3.29;
- 3. Section 3.23 (4) is hereby amended so that the final sentence now reads as "A person who starts a fire may be held liable and responsible for all suppression costs if the fire escapes and starts a wildfire";
- 4. Section 3.24 (3) is hereby amended so that the final sentence now reads "A permit for the sale of fireworks authorizes such sales only by persons or organizations legally qualified to sell products within the Town;
- 5. Section 3.30 (1) is hereby amended so as to update the reference from sec 3.42 to sec 3.31;
- 6. Section 3.33 (2) is hereby amended to strike the language "Chapter 7 of this Code" and replace it with "the Building and Construction Ordinance";
- 7. Section 3.33 (3) is hereby amended to strike the language "Chapter 7 of this Code" and replace it with "the Building and Construction Ordinance";
- 8. Section 3.33 (4) (c) is hereby amended to strike the language "Chapter 7 of this Code" and replace it with "the Building and Construction Ordinance";
- 9. Section 3.35 (3) is hereby amended so as to update the reference from §66.0627 to §66.60 (16);
- Section 3.37 (2)(a) is hereby amended so as to read "Fire lanes shall have an unobstructed width of twenty-four (24) feet. The edge of the lane closest to the building shall be at least 10 feet from the building;
- 11. Section 3.39 is hereby amended so as to substitute the work natural for the word live;
- 12. Section 3.40 (6) is hereby amended so as to read "UNAUTHORIZED REMOVAL OF KEYS PROHIBITED. No person, except authorized fire department, emergency medical service, or law enforcement personnel, shall remove any key from a key box without the authorization of the owner of the building", AND

- 1. Section 3.51 (1) is hereby amended to strike the language "a forfeiture as provided in §16.03" and replace it with "forfeitures as provided in Chapter 16";
- 2. Section 3.50 (1) is hereby amended to update the reference from sec. 3.26 to sec. 3.24.

This ordinance shall take effect upon enactment and posting or publication as required by law.
