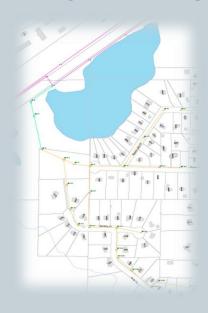

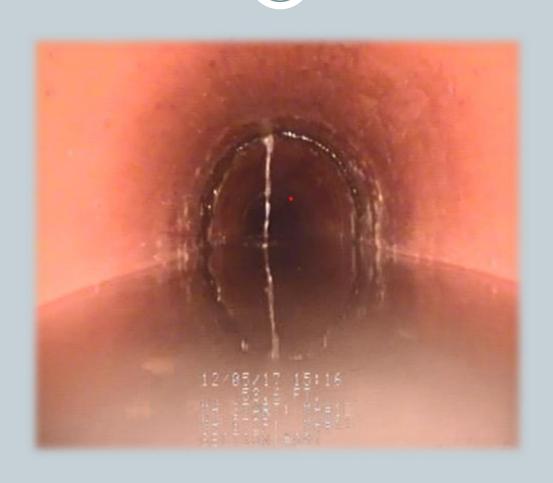

Dear Ms. Withee,

On Thursday, Oct. 26, 2023, the Madison Metropolitan Sewerage District Commission adopted the 2024 Operating and Capital Budgets, including the 2024 sewer service charge rates.

The table below provides estimated service charges for your community, based on the 2024 service charge rates and an estimate of your community's flow, pollutant loadings, equivalent meters, and customers. These estimates are based on historical trends, anticipated precipitation changes, and in some cases, knowledge of changes in industrial activity. If applicable, the table also includes estimated servicing charges for your community's pumping stations. Actual charges will vary from these values as wastewater measurements are taken each quarter in 2024.

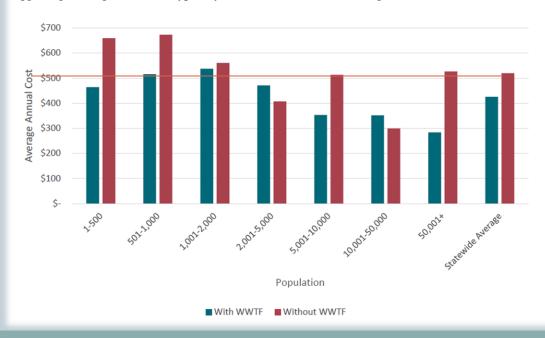

State Wide Rate Comparison

Figure 15 shows the average annual cost for residential sewer service in communities with and without their own wastewater treatment facility (WWTF). The trend of higher costs for communities with smaller population is evident for communities both with and without their own WWTF. In the smallest and largest population ranges, the average cost of residential sewer service is significantly higher for communities that do not own their own WWTF, suggesting that regionalization is less cost-effective for very small and very large communities. The statewide average annual cost for residential sewer service is approximately \$100 per year higher in communities that do not own their own WWTF, suggesting that regionalization typically does not offer a cost advantage.

Dear Town of Verona Sewer Utility District Customer:

Your property is served by the Town of Verona's sewer utility district. The system consists of 15,313 linear feet of pipe from 8 to 10 inches in diameter. The collected wastewater flows by gravity to a pump station located along Fitchrona Road, south of US 18/151, which is owned by the Madison Metropolitan Sewerage District (MMSD). The flow is then pumped to the MMSD Nine Springs Treatment Facility on the east side of Madison. MMSD treats the wastewater under contract with the Town. The system had no reported Sanitary Sewer Overflows or reports of basement backups in 2023. Work this year included the current abandonment of approximately 600 feet as part of a major MMSD capacity expansion project along the Badger Mill Creek in 2023-25. The project will relocate a section of the Town outfall sewer line near and under Goose Lake to connect to the new MMSD line to prevent water infiltration or collapse of older leaking sewer lines.

This district is funded separately from the Town's general fund; its operation is entirely dependent on user fees collected from residents who benefit from the system. The district meets its financial obligations through two accounts: an operating account and a reserve account. The operating fund pays for annual costs such as cleaning and sewage treatment costs. Treatment cost increases from MMSD projected for 2024 are estimated at 7.20%. Treatment costs will continue to increase as MMSD funds upgrades to the treatment facility and pumping system. A reserve account is a fund set aside to pay for capital improvement projects such as the Goose Lake area work, and unfunded events such as a pipe failure or manhole collapse.

Based on projected yearly expenses, an increase of 3.48% to the sewer rate is necessary for 2024. This proposed rate for next year and the year-to-date budget for the current year are both adequate to continue the process to maintain the both operating and reserve funds for the time being. The typical customer will see an increase in user annual fees from \$488.00 to \$505.00. The state-wide annual average user fee for sewer utilities the size of the Town is \$650.00.

The Verona Town Board will discuss and adopt the 2024 Budget (see reverse) at the annual Public Hearing for the Utility District scheduled for December 5, as an item at the Regular Town Board Meeting that starts at 6:30 p.m. The Public Hearing will be held at the Town of Verona Hall located at 7669 County Highway PD.
